# **GENERAL DESCRIPTION**

The turnip-cabbage strips are prepared from healthy, good peeled and washed turnip-cabbage of the genus Brassica Oleracea L.cv. gengulades L.

Cut size: 8 x 8 x length mm.

### **DESCRIPTION OF DEFECTS**

a) Colour variation : when the colour is different as aspected from the variety.

b) Small pieces : pieces shorter than 30 mm.

c) F.M. : this includes any non-vegetable material. Examples of foreign matter

include insects, pieces of insects, wood, glass, mineral stones, metal,

slugs, snails, toxic berries etc

d) F.E.V.M : this includes any vegetable material not derived from the cabbage

plant, and which is non-toxic.

e) Major Blemishes : black or brown discolouration covering an area bigger

than 6 mm.

f) Minor Blemishes : black or brown discolouration covering an area between

2-6 mm.

g) Badly peeled : parts of the skin attached.

h) Woody : hard pieces.

i) oversize  $:> 10 \times 10$
