GENERAL DESCRIPTION

The frozen mashed spinach portions are prepared from fresh, clean, healthy young spinach of the genus *Spinacia Oleracea*. The spinach has a uniform green colour and possess the typical own flavour.

The raw spinach is washed, afterwards blanched, cooled, mashed, formed and directly frozen.

REQUIRES AT THE FROZEN PRODUCT

- has to be a uniform green colour.
- free from foreign material and sand: max. 0.1 % ashes, insoluble in HCL.
- flavour and odour typical for spinach.
- portions: 4 to 6 g
