PRODUCTION PROCESS

Freshly harvested product is washed, centrifuged, individually quick frozen, chopped, sieved and packed.

Size: 1 –8 mm, 85% must be of the declared size

Country of origin: France

DEFINITION OF DEFECTS

a) FM : Any material not derived from basil or defined as EVM, e.g. insects, wood, metal, paper, plastic, toxic vegetable matter that would render the product unacceptable.

b) FEVM : This includes any vegetable matter not derived from the basil plant, and which is non-toxic.

c) EVM : Any vegetable matter other than basil, which is derived from the basil plant.

d) Oversize : cut size of the basil > 8 mm

e) Undersize : cut size of the basil between 0 - 2 mm

f) Clumps : which can not be separated by hand

g) Stalks : longer than 4mm and thicker than 1mm
