Skippy Creamy – Made from only the freshest peanuts and packed with great peanutty flavor. Spreads on smooth and creamy for maximum coverage. Great for sandwiches, dipping, or as an ingredient for baking and sauces.

Processing:

Skippy Peanut Butter is prepared by finely grinding select grade shelled, roasted, and blanched peanuts along with sugar, hydrogenated palm oil, and salt. This mixture is milled, deaerated and cooled, and the resulting peanut butter is filled into jars. The product complies with the Standard of Identity 21 CFR 164.150.

Target Texture: Uniformly ground peanut butter

Ingredient Listing:

Roasted Peanuts, Sugar, Hydrogenated Palm Oil, Salt.

This product contains peanuts (ground nuts).

GMO's / Natural:

Genetically modified crops undergo exhaustive testing and require the approval of the United States Department of Agriculture, Food and Drug Administration and Environmental Protection Agency. All ingredients used by Hormel Foods are Generally Recognized As Safe and comply with food safety and nutrition regulations. Skippy Creamy is not considered all natural due to hydrogenated vegetable oil.

Country of Origin Information for Ingredients:

To the best of our knowledge, at this time, peanuts in Skippy Creamy are derived entirely from peanuts grown in the United States. Additional ingredients are sourced domestically and internationally. Skippy® Creamy Peanut Butter is a product of the USA, manufactured in the USA.

Kosher Certification:

All varieties are certified OU.

Aflatoxin:

Strict quality control measures are effective in eliminating aflatoxin from finished products. Peanuts used to make Skippy peanut butter are tested for aflatoxin and must comply with Hormel Foods strict standards, which meet or are more stringent than the US government requirements. Based on FDA data, the sorting, grading, and inspection methods used by the peanut industry result in finished products that consistently average below 10ppb and in most years less than 5ppb. These levels are well below the FDA limit of 20ppb. Skippy Foods targets < 15ppb.
